

1. What is KA171 Mobility?

- > **The Project name**: «Partnership with Higher Education Institutions in Third Countries Not Associated with the Programme»
- > This activity covers projects that enable higher education institutions to carry out student and staff (academic and administrative) mobility by establishing partnerships with higher education institutions in third countries not associated with the programme.
- Higher education institutions with ECHE (Erasmus Charter for Higher Education) are required to apply to participate in the Erasmus+ Programme Learning Mobility activity.





1. What is KA171 Mobility?

- In KA171 projects, countries are divided into two main groups. These are:
- 1. <u>EU Countries and Third Countries Associated with</u> <u>the Programme</u> (formerly "Programme Countries"),
- 2. Third Countries Not Associated with the <u>Programme</u> (formerly "Partner Countries")

- In addition to these two main types, **«Short-Term Doctoral Mobilities»** also should be counted.


2. What are the main resources about KA171


- > There are two basic texts that we will follow when implementing the project. These are

• Our university was established by separating from Süleyman Demirel University with a law passed in 2018. Our university currently consists of 7 faculties, 19 vocational schools, 1 school of foreign languages and 1 graduate education institute. - > Implementation of the project will take place mainly in four phases. These are
 - 1) Bilateral Agreement,
 - 2) Preparation of Application Call for both Students and Staff,
 - 3) Evaluation According to the Selection Criteria,
 - 4) Preparation of Selection Report

Bilateral Agreement

• As a result of the fair and needs-based distribution of the budget prepared by us, the bilateral agreement drafts which include the numbers of mobilities sent to your parties must be approved by your legal representative and scanned; then sent to our institution via e-mail. After that, you will get the countersigned agreement by our side.

Preparation of Application Call for both Students and Staff

> An "Implementation Guide" is available on our website, which can help you with the preparation of calls for applications. Student and staff evaluations are expected to be carried out according to this Guide. If there are any mandatory criteria for student and staff evaluations in the directives, regulations or decisions of your organisation, you can include them in addition to the criteria in the Guide.

Evaluation According to the Selection Criteria

• Student and staff evaluations should be carried out in an open, transparent and accountable manner according to the determined criteria.

Preparation of Selection Report

 After the student and staff evaluation, the participants who are entitled to mobility should be listed in a table (if necessary, a draft can be sent by us) and signed and sealed by the "Erasmus Selection Commission" of your institution. The document should then be scanned and sent to us. Thus, we can keep track of who will come.

6. Applications of Participants Eligible for Mobility

> The documents to be prepared by the participants and our Office for the mobility to our organisation are detailed in the relevant "Checklists". In addition, downloadable draft versions of the documents in the Checklists are available in our current announcement on KA171.
